Dear Ian,

Thank you and the National Capital Pond organization for supporting Shenandoah Riverkeeper with a generous \$500.00 donation. Support from local groups such as yours is important to our work of stopping pollution and restoring clean water in the Shenandoah River and its tributaries.

This year, with our Agricultural Project Manager Alan Lehman's help, we have surveyed over 1,000 farms to identify sites that pollute streams with practices such as cows in the water and feedlots on the riverbanks. We are working with farmers to reform these practices and install measures such as fencing and stream buffers to protect the Shenandoah River. In some of the worse cases, we have filed complaints with the state. In addition, we continue to be vigilant about pollution from construction sites and industrial facilities, and to investigate fish health issues.
